

This volume explores the Indian artist, K. Venkatappa's (1886–1965) life, his works and the political and cultural contexts that influenced and inspired his art. It looks at the artist's style and examines the question of modernity in Indian art through the interstices of the regional and the national. This richly illustrated book contextualizes Venkatappa's work in the milieu of Calcutta and the Mysore state at the turn of the 20th century. Tracing both western and traditional Indian influences in his art, it historicises modern art and modernity in colonial India, at a time when boundaries, horizons and identities were shifting and going through great upheaval. The volume discusses Venkatappa's engagements with Indian artistic nationalism, the Bengal Renaissance, asceticism, as well as western modernist art and highlights the ambivalences and contradictions in his work that represent the shifts in ideas and identities at the time. Through an in-depth reading of the diverse contexts that Venkatappa engaged with, the essays in this book examine the artist's legacy and his relevance in contemporary artistic spaces in India.

It posits that harnessing sun, wind, and biomass can provide a sustainable economic alternative to polluting energy sources such as domestic coal and expensive oil and gas imports. Such a transition is projected to provide substantial benefits not only for the national economy but also for public health, the latter occasioned by the anticipated improvements in air quality resulting from the projected change in the energy system. Contrary to the concerns about the negative implications for economic development, the authors suggest that the transition to a carbon-free future offers a range of beneficial opportunities, especially for the youth in impoverished rural environments. Thus, they situate India's transition away from fossil fuels within the context of planet Earth's history, underscoring the abruptness of humanity's encounter with the reality of a potentially devastating and relatively immediate change in global climate.





The Indian National Army trials of 1945-46 have generally been given short shrift by historians in their cataloguing of the Indian freedom movement. In so doing, it unveils that, while the Indian National Congress' extended odyssey was essentially about a passive push-back, at a critical juncture of its campaign to extinguish British colonialism in India, it applauded and capitalised on the INA's use of force. The central, explosive narrative is about Britain holding a court martial of three officers of the INA — Shah Nawaz Khan, Prem Sahgal, and Gurbaksh Dhillon — convicting them, before a dramatic turn of events.

Until 40 years ago, we couldn't forecast weather conditions beyond ten days. Renowned climate scientist Dr. Jagadish Shukla is largely to thank for modern weather forecasting. Born in rural India with no electricity, plumbing, or formal schools, he attended classes that were held in a cow shed. Shukla grew up amid turmoil: overwhelming monsoons, devastating droughts, and unpredictable crop yields. His drive brought him to the Indian Institute of Tropical Meteorology, despite little experience. He then followed an unlikely path to MIT and Princeton, and the highest echelons of climate science. His work, which has enabled us to predict weather farther into the future than previously thought possible, allows us to feed more people, save lives, and hold on to hope in a warming world.
